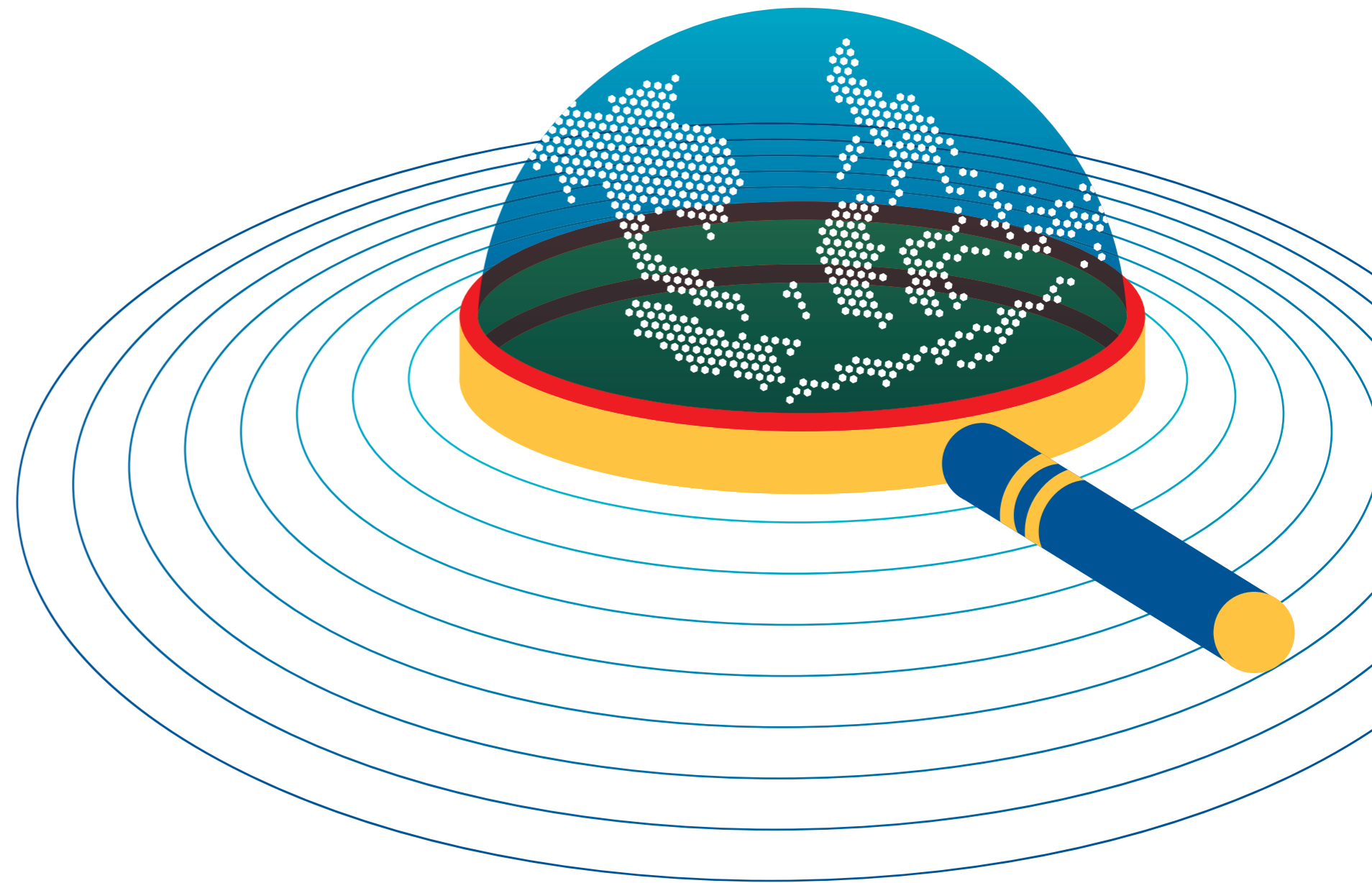

This *Mobility Funding Guide* is a concrete output of the mapping of funding opportunities for international exchange in 20 countries in Asia. It was first released on [culture360.asef.org](http://culture360.asef.org) in September 2012 by the Asia-Europe Foundation (ASEF) with the cooperation of Arts Network Asia (ANA), Korea Arts Management Service (KAMS), Japan Center, Pacific Basin Arts Communication (PARC), and Tokyo Performing Arts Market (TPAM).

The main objectives of this Guide are to make available online the existing information on funding that supports the international mobility of artists and cultural operators from Asia, and to provide input to funders on how to fill in the existing funding gaps for international cultural exchange in Asia.

This Guide follows the existing model of the *Guide to funding opportunities for the international mobility of artists and culture professionals in Europe* first produced by the Foundation Interarts, On the Move and PRACTICS.<sup>i</sup>

This Guide focuses on Asia (ASEM Asian member countries) and is organised around different themes, including culture and development.<sup>ii</sup> Nationals who do not have a dedicated country guide may be interested to check this Guide for additional sources of funding.

Only regular opportunities accessible online are listed when travels are at least partially funded for the selected candidates. Mention of Public, Private and Public/Private has been added next to the funding schemes to highlight the source(s) of the said funding. Not included are: funds for which information is only available offline, funds that are not based on open calls, and adhoc or short-term funding.

For a full over view of the methodology and scope of the research, please refer to the Mobility Funding Guide's *General Introduction*<sup>iii</sup>.

This Guide is an attempt to gather all the resources in one document, and is by no means complete. As we aim to update it on a regular basis through further research and input from the field, your feedback is crucial.

## **FUNDING OPPORTUNITIES - FOCUS ON ASIA**

### **1. ORGANISATIONS WITH A PARTICULAR FOCUS ON ASIA AND/OR SOUTHEAST ASIA**

#### **1.1. Asian Cultural Council**

**Description:** The Asian Cultural Council (ACC) supports cultural exchange in the fields of visual and performing arts between Asia, the United States and amongst Asian countries. Applications are accepted from individuals and institutions. The main focus of the ACC grant programme is awarding grants to artists, scholars and arts specialists from Asia for study, research, observation and related activities in the United States of America or in another Asian country. The ACC considers applications from Asian students pursuing graduate study in universities in the United States. Applications are not accepted for undergraduate programmes and the grant extends only to living expenses and international airfare. Applicants are encouraged to find other sources of funding for their tuition. Students must

apply separately to universities for acceptance while applying to the ACC for funds. (Private)

**Type of mobility:** Residencies, scholarships/postgraduate training courses, “go and see” or short-term explorations grants, support for the participation of professionals in transnational networks, “research” grants for scholarships

**Sectors:** Theatre, dance, music, painting, sculpture, photography, design, arts criticism, arts theory, installation, applied arts, video/new media, architecture, cultural heritage, research, cultural management

**Eligibility criteria:**

Nationality: Bangladesh, Brunei Darussalam, Cambodia, China, India, Indonesia, Japan, Korea, Lao PDR, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, U.S.A., and Viet Nam

Profession: Artists, cultural professionals, scholars, students

Other: Individuals are the priority (even if some groups can be supported to a limited level)

Destination: United States of America and Asia

Other priorities: A limited number of grants may be awarded to institutions for projects involving international exchanges in the arts between Asia, the United States and amongst Asian countries. Grants for projects are usually very modest in size as the ACC’s resources are focused on individual fellowships. The calls for applications open in the fall each year for grants starting in the springtime the following year.

## 1.2 Fundação Oriente

**Description:** The Fundacao Oriente awards short-term scholarships to applicants from Far Eastern countries, who wish to attend courses, under go training periods or field trips in Portugal. Scholarships are also awarded for the same purposes to Portuguese citizens undertaking similar work in Far Eastern countries. (Private)

**Type of mobility:** Scholarships/postgraduate training courses, “research” grants for scholarships

**Sectors:** Painting, photography, cultural heritage, research, architecture, design, art criticism, arts theory

**Sector:** Cinema

**Eligibility criteria:**

Nationality: Bangladesh, Brunei Darussalam, Cambodia, China, India, Indonesia, Japan, Korea, Lao PDR, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Viet Nam

Profession: Artists, cultural professionals, scholars

Destination: Portugal for Asian nationals

Other priorities: Short term scholarships (applications in June and December); research scholarships (applications in January)

Grant coverage: Depends on the length of the scholarship (1-3 months) and travel included

## 1.3 Arts Network Asia

**Description:** Arts Network Asia (ANA), set up by an independent group of artists, cultural workers and arts activists from Asia, is an enabling grant body working across borders in multiple disciplines that encourages and supports regional artistic collaboration as well as develops managerial and administrative skills within Asia. Arts Network Asia is motivated by the philosophy of meaningful collaboration, distinguished by mutual respect, initiated in Asia and carried out together with Asian artists and arts communities. It operates in 11 languages. ANA was created in 1999 by Ong Ken Seng (Artistic director of Theatretworks). ANA is funded through special funds from the Rockefeller Foundation and the Ford Foundation. (Private)

**Type of mobility:** Project and production grants

**Sector:** All

**Eligibility criteria:**

Nationality: Bangladesh, Brunei Darussalam, Cambodia, China, India, Indonesia, Japan, Korea, Lao PDR, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Viet Nam

Profession: Artists, art practitioners, art activists

Destination: Asia

Other priorities: Deadline for applications is usually once a year (even if less frequently since 2012). One of the objectives of the new ANA is to explore the potential of local-regional-global complementation, hence the projects related to inter-generations' local interactions, linking memories, local wisdoms and the future sustainabilities of cultures will be given priority.

Grant coverage: Maximum of USD 10,000 (travel grants of USD 1,000 are also available throughout the year). Applications to be submitted not later than one month before the event.

## 1.4 SEAMEO-SPAFA-Regional Centre for Archaeology and Fine Arts

**Description:** SEAMEO SP AFA, Regional Centre for Archaeology and Fine Arts, is part of the Southeast-Asian Ministers of Education Organization (SEAMEO), an international organisation dedicated to promoting co-operation in education, science and culture in Southeast Asia. Among other aims, SEAMEO-S PAFPA seeks to further professional competence in the fields of archaeology and fine arts through regional programmes and activities, and through sharing of resources and experiences.

The Centre collaborates with governments, institutions of its member-countries and associate member-countries, international agencies and academic communities, as well as non-governmental organizations and private sector bodies to carry out trainings, seminars, conferences, library and documentation services, staff exchanges etc. (Public)

**Type of mobility:** Events participation grants

**Sectors:** Painting, sculpture, photography, architecture, cultural heritage

**Eligibility criteria:**

Nationality: ASEAN nationals

Profession: Experts, practitioners in the field of archaeology, fine arts, conservation and cultural heritage

Destination: ASEAN countries or associate countries (rarely)

Other priorities: There is no fund as such but regular activities and programmes with possible open calls for applications

Grant coverage: Travel grants and accommodation for some projects (like forums, training, conferences etc.)

## 1.5 SEASREP Foundation

*Southeast Asian Studies Exchange Programme*

**Description:** The SEASREP Foundation, funded by the Japan Foundation and the Toyota Foundation, is a non-profit and non-stock organisation that aims to promote Southeast Asian studies in Southeast Asia by Southeast Asians through its projects and four grant programmes: language training, visiting professors, the Luisa Mallari Fellowships for M.A., the Ph.D. research in Southeast Asian Studies (run by the Manila office), and regional collaboration (run by the Tokyo office). (Public/Private)

**Type of mobility:** Scholarships/postgraduate training courses, event participation grants

**Sector:** Research



**Eligibility criteria:**

Age: Below 40 years for the Luisa Mallari Fellowship

Nationality: ASEAN member countries

Profession: For the Luisa Mallari Fellowship for M.A./Ph.D. research in Southeast Asian Studies: Southeast Asian nationals enrolled in social science or humanities graduate programmes in a Southeast Asian university. For the regional collaboration: any scholar in the humanities or social sciences who is a Southeast Asian national residing in the region, regardless of institutional affiliation.

Destination: ASEAN Countries

Other: Fellowships aim to foster mutual understanding, and reinforce cross-national cooperation and regional identity of Southeast Asia. Applications are accepted from February to September. The fiscal year runs from 1 April to 31 March. Applications are available from the Manila Secretariat, the Tokyo Joint Secretariat, the appropriate liaison officers of the 8 participating universities, and the Japan Foundation offices in the region.

Grant coverage: N.A. Apart from the above mentioned scholarships, there are regular calls for seminars and workshops for which travel grants and accommodation can be covered.

**1.6 Fukuoka Asian Art Museum (Japan)**

*Curators/Researchers-in-Residence Programme*

**Description:** The Fukuoka Asian Art Museum (FAAM) is the only museum in the world that systematically collects and exhibits Asian modern and contemporary art. The works in the collection of the museum are not imitations of Western art or repetitions of traditional works. Instead, they seek to overcome the existing framework of art being made by artists living in 'contemporary' Asia.

FAAM invites Asian artists, researchers and curators for an extended period of time in order to present various interactive programmes. The programme aims at enriching local culture, deepening understanding and interest in Asian art among the people of Fukuoka as well as position FAAM as a major centre for exchanging ideas and aesthetics through art. (Public)

**Type of mobility:** Residencies

**Sector:** Visual arts

**Eligibility criteria:**

Age: NA

Nationality: Bangladesh, Brunei Darussalam, Cambodia, China, India, Indonesia, Korea, Lao PDR, Malaysia, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Viet Nam

Profession: Artists, cultural professionals, scholars

Other: Researchers who possess a degree or experience and long-term prospects in the study of Asian modern and contemporary art. Curators who possess a degree or experience and long-term prospects in planning exhibitions of Asian modern and contemporary art.

Destination: Japan

Other priorities: The residency includes research on Asian contemporary art, the organisation of an educational programme and the presentation of the research. Call for the selection of one curator (70 days stay).

Grant coverage: Travel, accommodation, allowance, art exchange programme production costs, insurance

**Fukuoka Asian Art Museum**

**Type of mobility:** Artists' residencies

**Sector:** Visual arts

**Eligibility criteria**

Age: NA

Nationality: Bangladesh, Brunei Darussalam, Cambodia, China, India, Indonesia, Korea, Lao PDR, Malaysia, Maldives, Mongolia, Myanmar, Pakistan, Philippines, Singapore, Thailand, Viet Nam

Profession: Artists, cultural professionals, scholars

Other: People who already have a degree or experience in presenting their artwork or activities and have the potential for future growth in their field

Destination: Japan

Other priorities: Asian artists are invited to engage in making artworks, workshops and exhibitions. The residency includes an exchange programme with Fukuoka people, workshops and one exhibition. There is one call for applications with a residency period (maximum of 90 days) per year.

Grant coverage: Travel, accommodation, allowance, art exchange programme production costs, insurance

**1.7 The Japan Foundation – Asia Center**

*Grant Programme for Promotion of Cultural Collaboration*

**Description:** The Japan Foundation Asia Center carries out mutual exchange programs and cooperative work between the people of Asian countries and regions. (Public)

**Type of mobility:** Project and production grants, travel grants

**Sectors:** All

**Eligibility criteria:**

Nationality: ASEAN countries and Japan

Profession: organisations, individuals

Other: Collaborative projects in 10 ASEAN countries or Japan such as co-production and joint research, and projects to disseminate the results of these collaborative projects, implemented mainly by specialists/specialist organizations in the fields of culture and arts, sports, or intellectual exchange in the target areas. As long as Japanese organizations or individuals are involved, bilateral collaborative projects as well as multilateral projects that involve countries other than the target areas are also eligible.

Destination: Japan, ASEAN countries

Grant coverage: The grant will provide partial coverage of expenses including travel and accommodation, loan of venue, equipment hire, and interpretation and translation costs.

*Fellowship Programme*

**Description:** The Japan Foundation Asia Center carries out mutual exchange programs and cooperative work between the people of Asian countries and regions. (Public)

**Type of mobility:** Project and production grants, travel grants

**Sectors:** All

**Eligibility criteria:**

Nationality: ASEAN countries and Japan

Profession: specialists (see below)

Other: Specialists who are nationals of and permanent residents in Japan or 10 ASEAN countries, and who are engaged in research, creative activities and building networks and platforms in fields such as arts and culture, sports, and intellectual exchange.

Destination: Japan, ASEAN countries

Grant coverage: Travel expenses: International airfares (discount economy class fares), Living and Activity Expenses, Overseas Travel Insurance

## 1.8 International House of Japan and the Japan Foundation

### *Asia Leadership Fellow Programme*

### 3.7 Harvard University – South Asia Institute (USA)

#### *Programme for Visiting Artists from South Asia*

**Description:** The Harvard University South Asia Institute's Arts Programme serves as a resource across all disciplines to explore critical issues of South Asia through the lens of art and design. The Programme welcomes applications from emerging artists in South Asia to come to Harvard University to participate in interdisciplinary discourse with students and faculty on global issues relevant to South Asia. (Public/Private)

**Type of mobility:** Event participation grants, Training

**Sectors:** All (any medium)

**Eligibility criteria:**

Nationality: South Asia: India, Pakistan, Bangladesh, and Myanmar

Profession: Artists

Other: This opportunity is meant to recognize and showcase the artwork of up-and-coming artists who would greatly benefit from facilitated connections with Harvard faculty and students and the opportunity to show their work at Harvard University. Up-and-coming artists must either be between 20–35 years of age or have limited international exhibits and residencies.

Destination: Harvard (USA)

Grant coverage: Each artist receives USD 1,000 of discretionary funds (not accounting regional taxes) after their visit. This modest discretionary fund is meant to cover the artist's exhibit related costs and cultural excursions in the New England area. The costs of each artist's economy travel, accommodation for the two weeks, and meals are provided.

**3.8 International Education Institute***Artist Protection Fund*

**Description:** The Artist Protection Fund (APF) is a three-year pilot programme at the Institute of International Education. With funding from the Andrew W. Mellon Foundation, APF will make life-saving fellowship grants to threatened artists from any field of artistic endeavor, and place them at host universities and arts centers in safe countries where they can continue their work. (Public/Private)

**Type of mobility:** Artists' residency, travel grants

**Sectors:** All

**Eligibility criteria:**

Nationality: International

Profession: The Institute welcomes inquiries from threatened artists directly or from individuals or institutions nominating threatened artists for support. APF is for artists who are facing or have recently fled from immediate, severe, and targeted threats to their lives and/or careers in their home countries or countries of residence.

Destination: International

Grant coverage: Total fund is USD 2.79 million

**3.9 The Abraaj Group***Art Prize*

**Description:** The Abraaj Group, a leading private equity investor operating in global growth markets has been developing for 9 years the Abraaj Group Art Prize. (Private)

**Type of mobility:** Project and production grants, event participation grants

**Sectors:** Visual arts

**Eligibility criteria:**

Nationality: South Asia

Profession: Artists/Curators

Other: Experienced international and regional curators are also invited to apply to become Guest Curator of the Abraaj Group Art Prize

Destination: In 2016: Dubai and other venues (museums, art fair) as the artist becomes part of the artist Abraaj Group Art Collection

Grant coverage: As in 2016, one winning artist is awarded a USD 100,000 prize to create a major new commission. 3 shortlisted artists will also be chosen to receive a cash prize of USD 10,000 and showcase their work alongside the winning work in a thematic exhibition.

### 3.10 European Audiovisual Entrepreneur (EAVE)

*Ties That Bind (Asia-Europe Producers)*

**Description:** Ties That Bind – Asia-Europe Producers Workshop was organised in 2012 in partnership with Friuli Venezia Giulia Audio-visual Fund, EAVE, Udine Far East Film Festival and Busan International Film Festival/Asian Project Market, and supported by the European Union programme MEDIA Mundus. This is the fourth workshop in the series.

The programme is articulated around 2 workshops. The first workshop takes place at the Udine Far East Festival and second at the Busan International Film Festival. The workshop brings together 10 film producers from Asian and European countries. Each producer is selected together with a feature film project in development and works with leading industry experts from both continents during the 2 workshops. (Public)

**Type of mobility:** Events participation grants (for project development), market development grants

**Sector:** Cinema

#### **Eligibility criteria:**

Nationality: Asia (Cambodia, China, Indonesia Japan, Korea, Lao PDR, Malaysia, Mongolia, Myanmar, Philippines, Singapore, Thailand and Viet Nam) and Europe

Profession: Experienced film professionals with a film in development stage suitable for an international co-production

Other: The producer must have completed at least one film released theatrically in the last 3 years; the 1st draft of the script for the submitted project must be available in English for the workshop.

Destination: Italy (Udine) and in Asia (Singapore in 2016 for the Southeast Asian Film Financing Forum)

Other priorities: Projects suggested by Asian applicants should have a potential for co-production with Europe, and projects suggested by European applicants should have a potential for co-production with Asia

Grant coverage: The participation at Ties That Bind is free of charge. Each participant will be offered accommodation (full board including meals) for the duration of the workshop. In addition, Ties That Bind will offer a number of partial scholarships to contribute towards travel costs.

### 3.11 International Film Festival Rotterdam, The Netherlands

*Rotterdam Lab*

The Rotterdam Lab works closely with partner organisations in several countries. Applications can be submitted through these organisations only. (Public/Private)

**Type of mobility:** Events participation grants, market development grants

**Sector:** Cinema

#### **Eligibility criteria:**

Nationality: For 2015: Singapore

Profession: Film producers (young and upcoming) who should have produced at least one or two short films, and not more than two feature films

Destination: Rotterdam

Other priorities: Selected through partner organisations

Grant coverage: NA

**Type of mobility:** Event participation grants, touring incentives for groups

**Sectors:** Performing arts, music

#### **Eligibility criteria:**

Nationality: Depends on the year but Asian countries often included (like Pakistan in 2017)

Profession: Nominations may be submitted by presenters, artists and their representatives, U.S. embassy personnel, regional arts organizations, state arts agencies, and individuals in the U.S. that are knowledgeable about performing arts ensembles in the identified countries.

Other: Artists interested in participating may submit a nomination on behalf of their own ensemble

Destination: United States of America

Other priorities: The visiting artists should have an interest in engaging with U.S. communities, including youth, through public and in-school performances, workshops, discussions, artist-to-artist exchanges, and social events

Grant coverage: Travel, accommodation, tours etc.

Other: In addition to full-time professional musicians, invitation is also extended to adventurous musicians who double as community organizers, instrument builders, writers, videographers, musicologists, educators, storytellers, dancers, shadow-puppeteers, and more.

Destination: United States of America

Other priorities: Interested in collaboration and socially engaged music work

Grant coverage: The OneBeat programme covers all fellows' travel, transportation, food, and lodging costs
