#### **Background**

The Mobility Funding Guide for Australia is a concrete output of the mapping of funding opportunities for international exchange in 20 countries in Asia. It was first released on culture360.ASEF.org in 2015 by the Asia-Europe Foundation (ASEF) with the cooperation of Arts Network Asia (ANA), Korea Arts Management Service (KAMS), Japan Center, Pacific Basin Arts Communication (PARC), and Tokyo Performing Arts Market (TPAM).

The main objective of this Guide is to make available online the existing information on funding that supports the international mobility of artists and cultural operators from Asia, and to provide input to funders on how to fill in the existing funding gaps for international cultural exchange in Asia.

This Guide follows the existing model of the *Guide* to *funding opportunities* for the international mobility of artists and culture professionals in *Europe* first produced by the Foundation Interarts, On the Move and PRACTICS.

This Guide focuses on Asia (ASEM Asian member countries) and is organised around different themes, including culture and development. Nationals who do not have a dedicated country guide may be interested to check this Guide for additional sources of funding.

Only regular opportunities accessible online are listed when travels are at least partially funded for the selected candidates. Not included are: funds for which information is only available offline, funds that are not based on open calls, and ad hoc or short-term funding.

For a full overview of the methodology and scope of the research, please refer to the Mobility Funding Guide's *General Introduction*<sup>ii</sup>.

This Guide is an attempt to gather all the resources in one document, and is by no means complete. As we aim to update it on a regular basis through further research and input from the field, your feedback is crucial.

#### Introduction

In Australia, both public and private organisations offer various funding opportunities to support the cross-border travel of artists and arts and cultural professionals to and from the country. The organisations listed here include those that provide regularly recurring mobility funding to and from Australia. Only opportunities with clear, accessible information available online have been included.

At the national level, Creative Australia is the primary funder for international mobility (among other schemes) for individual artists and arts professionals. Creative Australia is a government-funded body that makes decisions primarily through a peer-review process. The Department of Foreign Affairs and Trade also has a number of institutes focused on particular countries or regions which are deemed a priority (many of which are in Asia).

There are six states and two territories in Australia, each of which has its own funding bodies in arts, film and regional arts that, among other things, fund international mobility. This funding is often restricted to residents of the states and territories, although there are some schemes that support the invitation of international artists. In addition, there are many cities and local councils that also have arts funding schemes. These are particularly strong in the capital cities, although they can also be found in other councils. The arts schemes of the capital cities (such as Adelaide, Canberra, Darwin, Hobart, Melbourne, Perth, or Sydney), were not included here as they do not explicitly say that they fund international mobility. However, they all focus on presenting cultural work within their borders, and this could include international invitees, therefore it could be worth contacting the arts funders directly about eligible funding costs. Other local councils were not included in this guide (apart from a few exceptions) as the research required to check the over 500 councils individually lie outside the scope of this research.

There are a number of national and state cultural bodies (such as the National Library or National Museum of Australia) that offer funded programmes, as well as universities or education institutions. Although some key institutions were included here, an extensive investigation into each tertiary institution was outside the scope of this research, but it could be valuable to check these institutions for funding programmes (including short term funding programmes). Additionally, there are many universities that offer PhD practice-led research programmes that are open to international students (with yearly stipends), which are also worth investigating for creative practitioners interested in further study.

For the private sector, many of the organisations included residency programmes. In addition to those listed, there are many residency programmes that offer partial support (such as free accommodation and no fees) or those that charge fees to the artist. These are not included in this guide as they only offer partial or no support. In other cases, there are fees provided for exhibitions at Australia-based galleries, although they are in theory open to international applicants, the mobility responsibilities are borne by the artists, so they have not been included here. Some examples include the <u>Science Gallery Melbourne</u> or <u>firstdraft</u> gallery in Sydney, which has collaborations with other States, such as the <u>ACE x firstdraft Short-term Residency</u> with South Australia and which also offers travel fees for interstate travel. The private organisations also include associations and non-for-profit organisations, which, in some cases, receive support from government funders for project or organisational support.

Some international organisations are listed when they have particular programmes targeted at Australian or Commonwealth artists or creative practitioners. Other international programmes open to any nationality are not listed here (you can refer to the list of <u>funding guides for each country</u> to access these international opportunities).

One topic worth mentioning regarding mobility in the Australian context is the challenge of national mobility, especially to and from remote and very remote Australia (approximately 75% of Australia's landmass is considered very remote by the Australian Bureau of Statistics, with limited access to services and infrastructure). Additionally, the distances involved in travelling across Australia are vast (the Australian mainland stretches nearly 4,000 kilometres from east to west and nearly 3,200 kilometres from Cape York Peninsula in the northeast to Wilsons Promontory in the southeast). This makes it expensive and difficult to tour work to remote areas (for national or international artists) and in addition, it can be more expensive for artists and cultural practitioners who live in remote areas to travel.¹ This can lead to remote populations having less access to diverse cultural offerings and it can also make it very difficult to develop a sustainable creative practice in remote areas (which can lead to artists and cultural practitioners relocating to state and territory capital cities).

There are some funders who address this through regional touring programmes or funding specifically targeted at regional, remote and very remote areas (which is particularly urgent in Western Australia, the Northern Territory, South Australia and Queensland). Not all of these funds are open to international artists and some are focused on state/territory or national mobility more than international mobility. However, although it is not always stated, some of these regional funds could potentially include an international component, so artists interested in working in regional or remote areas in Australia could approach local partners to investigate potential collaborations.

In addition to the regional arts bodies (such as the Regional Arts Fund, Country Arts South Australia or others) there are also some other organisations that promote national mobility, such as <u>Dancehouse's call for works</u>, <u>Australian Theatre for Young People's National Studio programme</u> that supports emerging writers to stay in rural New South Wales, or <u>The Cad Factory's Scene Shift Residency Programme</u> between urban and rural spaces, to offer just a few examples.

The last section lists a few relevant sources of information or key peak bodies, which readers can refer to in order to research more ad hoc funding opportunities or investigate touring or collaborating in Australia.

#### 1.1. Australian Government – Department of Foreign Affairs and Trade (DFAT)

1.1.1. Australian Cultural Diplomacy Grants Programme

#### Description

The Australian Cultural Diplomacy Grants Programme (ACDGP) supports international projects that tell Australian stories, amplify First Nations voices, deepen bilateral partnerships, and build cultural understanding and connections overseas. The intended outcomes of the ACDGP are increased collaboration and partnerships between Australian and international organisations/individuals in the arts and cultural sectors; increased Australian capacity to effectively engage with overseas partners, especially in the arts and cultural sectors; and enhanced reputation and influence for Australia internationally.

#### Type of mobility

- ⇒ Project or production grants
- $\Rightarrow$  Event participation grants (networks, festivals, meetings etc.)
- ⇒ "Go and see" or short-term exploration grants
- ⇒ Market development grants
- ⇒ Touring incentives
- ⇒ Capacity building / Professional development programmes

#### **Sectors**

#### Eligibility criteria

Nationality: Permanent resident of Australia or based in Australia

**Profession:** Organisation, a government body or an individual

**Destination:** Australia, international

#### Other priorities:

Favourable consideration will be provided to:

- ⇒ Projects that are multi-country in scope or strengthen regional engagement in support of the objectives:
- ⇒ Projects delivered in the Pacific, including Papua New Guinea;
- ⇒ Applications with identified international partners;
- ⇒ Applications from First Nations people and organisations
- ⇒ Projects that are delivered outside of Australia

Applicants are encouraged to seek funding support and partnerships with other areas of government, corporate sponsors, and private partners.

**Grant coverage:** Available individual project funding ranges in size from 10,000 AUD and is capped at 60,000 AUD. Eligible costs include:

⇒ Cross-border travels

- ⇒ Accommodation costs (up to 4 stars accommodation properties as a guide)
- ⇒ Per diem
- ⇒ Production costs
- ⇒ Others (communication, etc.)

#### 1.1.2. ASEAN-Australia Centre Grants Programme

#### Description

The Centre's first Grants Programme funds Australian businesses, creative industry, community, education and cultural organisations to deliver projects, programmes and research with Southeast Asian partners.

**Nationality:** Citizen, permanent resident of Australia or be based in Australia. Applicants can also be located in an ASEAN member state or Timor-Leste

**Other priorities**: It delivers programmes and initiatives across its four strategic pillars – Southeast Asia literacy, economic linkages, education and cultural connections.

Grant coverage: 10,000 AUD to 60,000 AUD

#### 1.1.3. National Foundation for Australia-China Relations Grant Programme

#### Description

The Foundation's grant programme aims to promote and coordinate enhanced cooperation between Australia and mainland China, Hong Kong and/or Taiwan, in support of Australia's national interests and the Australia-China Comprehensive Strategic Partnership. The aims are to

strengthen risk-informed engagement with China, in Australia's national interest and to reinforce social cohesion by engaging Chinese Australians, showcasing their contribution and strengthening their voice and agency.

- ⇒ "Go and see" or short-term exploration grants
- ⇒ Market development grants
- ⇒ Touring incentives
- ⇒ Travel grants (valid for different purposes)

- ⇒ Capacity building / Professional development programmes
- ⇒ Scholarships for further / postgraduate training courses

**Nationality:** Citizen, permanent resident of Australia or be based in Australia. Applicants can also be located in mainland China, Hong Kong and/or Taiwan

**Profession:** Artist, organisation, government body

Other: The maximum grant period is four years

**Grant coverage:** 100,000 AUD to 500,000 AUD for the following:

- ⇒ Cross-border travels

#### 1.1.4. Centre for Australia-India Relations Maitri Grants

#### Description

The Maitri Grants administered by the Centre support greater exchange and collaboration between Australian and Indian cultural, education, research and business communities. Through this programme, the Centre encourages innovative projects and partnerships that reflect the dynamism of the bilateral relationship, fostering life-long connections in trade, education, innovation, research, arts, and culture.

- ⇒ Event participation grants (networks, festivals, meetings etc.)

#### **Sectors**

#### Eligibility criteria

**Nationality:** Applicant organisations can originate from any country; however, they must be able to operate in Australia

Profession: Businesses, non-governmental organisations, academic institutions, or other entities
