The title of the conference is "Cultural Policies in Democratic and Nondemocratic Regimes".

Cultural policies in democratic and non-democratic environments have historically been influenced by different cognitive perspectives. Non-democratic regimes sought to consolidate power and control culture, while democratic states valued freedom of expression and provided a general framework for artists. Today, cultural policies aim to defend global culture, and it's the ideologies behind them that have changed over the years.


