As part of this major international congress, the **8th Annual ENCATC Research Session** will be held on Friday, 29 September. Submissions of abstracts or thematic session proposals are welcome that relate to the 2017 Congress theme or any relevant discipline will be considered, provided that they make an original academic contribution to the study of arts management and cultural policy.

Topics of interest are related to the main Congress theme, “Click, Connect and Collaborate! New directions in sustaining cultural networks”:

- Networks governance leadership
- Business models
- Evaluation processes and methods
- Internationalization of networks

All accepted papers will be published in an electronic book of proceedings (with ISBN) which will be published for the Congress. The electronic book of proceedings may include papers in English and French.
