## GUIDELINES

Korea Arts Management (KAMS) announces a call open to international organisations planning to present exhibitions of Korean artists. Grants are available to support such exhibitions in order to introduce Korea's contemporary visual arts to an international audience and further international exchanges.

Full details are available on the KAMS website. Grant applications may be made by the eligible international art organisation or by the Korean artists. Collaborative programmes between international art organisations and Korean partners are also eligible. Grants will be awarded to the Korean partner or Korean artist.

To be eligible for this grant programme, the artworks **MUST** be available for **SALE** in the exhibition venue. Exhibitions must be held between April 2018 and December 2019.

**Deadline for applications: 28 February 2018**

Initiated by Korea Arts Management Service (KAMS), is an international market development grant program whose mission is to support and promote the presentation of Korean performing arts on the international stage.

Center Stage Korea partners with promoters, performing arts centers, theatres, and others staging Korea-focused performing arts programs.

#### Eligible Projects

- A single festival or venue presenting a Korea-focused program featuring multiple Korean performing artists/companies
- A tour arrangement featuring one or more Korean performing artists' companies with no previous (prior) representation in target markets

\*Tour length must occur between March and September 2015.

#### Who Can Apply

- International promoters/presenters of festivals, performing arts centers, and networks

#### Required Documents

- Completed KAMS proposal application
- Additional documents or other materials demonstrating previous projects

#### Grant Terms

- New Center Stage Korea Korea grant provides assistance with transportation costs.
